# **CPAC 101**

#### What is a PAC?

"PAC" is short for Political Action Committee. It is established to raise money that will be used to elect or defeat candidates. The history of the PAC goes back to 1944 and has become increasingly common ever since. They are highly regulated and all their records are public.

#### What is the OSCA's PAC?

The OSCA created the Chiropractic Political Action Committee, also referred to as C-PAC. It was created in 2003 and has been the leading PAC in Ohio for advocating and electing prochiropractic candidates ever since.

## Why does the OSCA have a PAC? Why is it important?

C-PAC stands up for Ohio's chiropractic industry by helping elect and re-elect Ohio's state representatives and senators who support the Ohio State Chiropractic Association's public policy agenda. By electing pro-chiropractic legislators, the OSCA is given the unique opportunity to shape public policy in favor of the chiropractic industry. Additionally, C-PAC gives our legislative staff the ability to play a significant and effective role while meeting with legislators in and around the Ohio Statehouse



### How can you help the PAC?

Everyone can help the PAC, member or not. The best way to help out is to sign up for monthly donations. If you donate \$50/month, you automatically become a member of our 1895 Club! We understand that this might not be possible for everyone, so you can also make one-time donations whenever you like. Just remember that these donations must be made from personal accounts, not business accounts, and are limited to \$12,707.79 per individual per calendar year.

### **How is C-PAC money distributed?**

When the OSCA does decide to contribute to candidates, they are evaluated on a case-by-case basis. The Executive Director compiles any and all requests from state candidates and politicians. Funds over \$500 are allocated by the OSCA Legislative and Regulatory Affairs Committee. Funds over \$5,000 must be approved by the OSCA Board of Directors. In each instance, multiple factors are taken into consideration, including past endorsements, voting records, and support of the chiropractic message.
