## Mark your calendar now -- CCSP program coming in 2023!

120 hours, May 2023-February 2024

You asked for more in-person, hands-on technique classes, and programs that focused on treatment of the athlete. The OSCA is pleased to announce our partnership with the University of Bridgeport to bring a 120 CCSP program to Ohio!

This hybrid program will consist of eight in-person weekends and 24 hours of online learning. Starting in May, you will be in-person for two weekends, and then have the majority of the summer months off for the online hours. You start back in the fall with in-person training.

We'll be bringing the experts to Ohio so that you don't have to travel out of state for the best, up-to-date training and information.

### Other perks:

- You will be eligible to sit for the CCSP upon completion of the course
- Instructors include Dr. Timothy Ray and Dr. James Lehman
- Creates a pathway for those wishing to work with concussed athletes
- Hybrid class gives you the benefits of in-person, hands-on training with the flexibility of some virtual learning hours
- The 120-hour program will also be applicable for the Diplomate credentials for either Sports Chiropractic and/or Chiropractic Orthopedics/Neuromusculoskeletal Medicine

## Insurance Updates

### Medicaid

#### Next Generation Ohio Medicaid program

Over the past year, Ohio Department of Medicaid (ODM) has prepared for and launched many components of the Next Generation Ohio Medicaid program. The implementation has followed two key Next Generation commitments – to focus on the individual and improve the provider experience.

To meet these commitments, on July 1, ODM implemented OhioRISE (Resilience through Integrated Systems and Excellence) and on October 1, implemented the Single Pharmacy Benefit Manager (SPBM) and Centralized Credentialing for providers.

ODM's focus has been and continues to be on implementing new components and improvements. They are committed to listening to members, providers and managed care plan partners, and have taken a hands-on approach to resolving implementation issues that have been experienced by providers. Leading up to the next implementation, ODM has been actively seeking input

from stakeholders and conducting testing of all systems.

### **What does this mean for providers?**

Based on the feedback ODM has received and their commitment to carefully transitioning, ODM will not implement the new Next Generation managed care plans and the full Ohio Medicaid Enterprise System (OMES) launch on December 1.

The new lineup for implementation is as follows:

- **On February 1, 2023**, ODM will launch the **Next Generation managed care plans** and program requirements, including exciting improvements that will support members in accessing the healthcare services and supports they need. ODM will also implement the **new Electronic Data Interchange (EDI)**, increasing transparency and visibility of member care and services.
- Subsequently, ODM will fully launch OMES modules to provide streamlined processes for claims, prior authorizations, and other administrative tasks for providers.

**Providers should continue conducting business as you do today on and after December 1** – including the processes, procedures and systems used today to submit claims, prior authorizations and complete other administrative functions.

ODM will provide more information about the upcoming implementation for members and providers in the coming weeks.
