House Bill 151

Last month, the OSCA announced some changes made to House Bill 151. These included the removal of all the CE language, a reduction in penalties for the loan repayment program, and the addition of language to fix a current law regarding animal chiropractic. While the new substitute bill was approved by the House Health and Human Services Committee, discussions are continuing over language for the final version of the bill. The OSCA has been working with the Ohio State Chiropractic Board, the Ohio Veterinary Medical Association and Ohio legislators over the past few weeks to finalize language for the bill. As this progresses, we will update members with any additional changes or progress!

OSCA Dues Reminder
