2022 OSCA Dues Thank you for your membership!

As a reminder, with the 1st quarter dues

If you do not want to pay these optional charges, please take the appropriate action listed below.

- If you have already opted-out, please check the upcoming dues invoice on you member profile. It should show the adjustment. If it does not, please email us at osca@oscachiro.org.
- If you would like to opt-out from one or both optional charges, but have not done so, please email us at osca@oscachiro.org and state opt-out in the email so we can ensure your profile is updated.

Dues will be running on December 15th, so you must act before that date to ensure your proper dues run.

Insurance and Legislative Updates

<u>2022 Medicare Fee Schedule:</u> The OSCA has posted the 2022 Medicare Fee schedule, as published by CMS. As expected, there was an estimated 2,5% cut made across the board, not just affecting chiropractors. <u>Click here to view the new fee schedule.</u> This goes into effect on January 1, 2022. As you may recall, changes to last year's fee schedule were made into the new year. While we do not expect changes, we will monitor CMS to ensure you have the most

updated version on our Medicare Members-only page.

<u>CareSource Policy</u>: The OSCA is aware that multiple offices have been informed by CareSource during benefit verifications that there is no annual visit limit for chiropractic spinal manipulation. This is not consistent with CareSource's published policy or with the OAC rule 5160-8-11.

Upon inquiry by OSCA to CareSource leadership, they confirmed that CareSource maintains the visit limit as defined by Medicaid. If you have an example of mis-verification of benefits by CareSource regarding spinal manipulation visit limits, please email your information to Dr. Spaulding at <u>brandy@oscachiro.org</u>. Your email must contain a reference number and date for a phone call in which you were given inaccurate information, or written or electronic communication from CareSource that states there is no visit limit.

<u>Medicare Attestation</u>: The OSCA has received multiple inquiries on how to handle Medicare Attestation. Once a year, providers are required to attest to Fraud, Waste and Abuse Training and Compliance for Medicare.

Medicare Replacement Plans are required to ensure that their providers are attesting to this requirement. Once you have attested once for the year, it should satisfy the requirement for all Medicare replacement plans.

AETNA/ASH partnership: The OSCA has been in contact with Aetna to gain additional clarification on their new partnership with ASH to administer a new supplemental Medicare plan beginning on January 1st, 2022. Based on conversations with Aetna, we believe that this partnership should only affect that new supplemental plan, not their Medicare replacement offering. Therefore, Ohio DCs should not have to participate with ASH to maintain their network status with Aetna's commercial or Medicare plans. We are awaiting further clarification on this issue and will communicate any changes to members accordingly.

CMS Vaccine Mandate Clarification

The Centers for Medicare & Medicaid Services (CMS) released its Interim Final

rule in November, following its September announcement that eligible employees in all facilities receiving Medicare and Medicaid reimbursements would be subject to mandatory vaccination requirements.

The interim final rule provides additional information and clarification regarding who, and which facilities, will be impacted by this requirement. Consistent with the original September announcement, the rule continues to focus on facilities that receive reimbursements. Upon review of the information provided in the rule, private practice providers contracted with Medicare as non-facilities are not subject to the mandatory requirement. This remains consistent with the original notice that OSCA put out on September 10, 2021.
