

Insurance and Legislative Updates

UPDATE: Ohio Medicaid Episode of Care Provider Reports for 2018/2019

Some Ohio DCs started receiving letters last week from Ohio Medicaid Managed Care Plans. These letters identify the provider as a Principal Accountable Provider (PAP) in the ODM Episodes of Care Program. Based on the Episode of Care Provider Reports from 2018 and 2019, the letter is notifying the provider of a positive or negative incentive for the corresponding time frame. If a positive incentive is applied, providers are told to expect their

incentive payment by in April. If a negative incentive is applied, the provider is notified of the amount that must be paid back.

We have reached out to the specialty team at Medicaid regarding this program. What we need from you: If you received a letter, please forward it to Dr. Spaulding at brandy@oscachiro.org so that we may see how this program is impacting Ohio DCs.

The program incentives, including positive and negative incentives, have been suspended for calendar years 2020, 2021 or 2022.

UPDATE: When the Ohio Senate returned from their winter break in late January, HB 136 was on the agenda for the first Senate Health Committee meeting of 2022. On January 26, HB 136 received its fourth and final hearing in that committee and was unanimously passed by committee members.

HB 136 will improve access to chiropractic care in Ohio by requiring coverage of E/M services in Medicaid and preventing prior authorization requirements for covered services in Medicaid. The next and final step for this bill is the Senate floor.

Compliance

No Surprises Act Compliance for Chiropractors

UPDATE: January's newsletter contained valuable information for compliance with the "No Surprises Act."

Part 2 requires state licensed or certified health care providers, including chiropractors, to provide a <u>Good Faith Estimate</u>, (GFE) of the cost of the patient's healthcare services to every patient who is uninsured or is not planning on submitting a claim to their insurance for their services.
