Insurance Updates

<u>CareSource Take Backs on Acupuncture:</u> Last year, the OSCA was made aware of improper take back requests from a third party on behalf of Caresource. These requests were for acupuncture services. After a meeting with the OSCA, Caresource acknowledged the error and has reversed all take back requests. Any office that has received these requests, please disregard them and continue to bill acupuncture services per usual.

BWC Timed Service Codes Update: The OSCA continues to worked with the Ohio Bureau of Worker's Compensation on their policy of Timed Service Codes. While there is no start date, as of yet, for this new policy to go into effect, the bureau sent out a message to all the MCOs that they should not be denying any claims on the basis of this policy. If you received any improper denials, they should be reversed and DCs should see claims paid in the near future.


