

Insurance and Legislative Updates

<u>UPDATE 2022 Medicare Fee Schedule:</u> As expected, Medicare has made changes to their 2022 Fee Schedule that was originally published in November 2021. Access the new fee schedule <u>here.</u> Additional changes to the fee schedule may occur between now and March. The OSCA will continue to provide updates as needed.

The American Chiropractic Association will be hosting a virtual advocacy day on **Thursday**, **Feb. 24**, **2022**.

This day is dedicated to virtual meetings with congressional representatives to advocate for HR2654, federal legislation that would allow DCs to be paid for the full scope of their services within Medicare, instead of the current payment model, which covers CMT only.

Compliance

No Surprises Act Compliance for Chiropractors

As of January 1, 2022, chiropractors and all other licensed healthcare providers will need to comply with the No Surprises Act (NSA), designed to protect patients from unexpected medical bills.

Part I, effective on July 1, 2021, primarily impacted facilities and therefore, chiropractors were largely not included in this requirement. However, part 2,

effective on January 1, 2022, impacts licensed healthcare professionals, including chiropractors.

Part 2 requires state licensed or certified health care providers, including chiropractors, to provide a **Good Faith Estimate**, (GFE) of the cost of the patient's healthcare services to every patient who is uninsured or is not planning on submitting a claim to their insurance for their services.
