<u>Individual Coverage Health Insurance:</u> You asked, and we answered! OSCA is now able to offer individual members a health insurance option! With this plan, you do not need to have another employee or family member to apply for OSCA health insurance. This plan will now be offered to all OSCA members who are interested.

What's new in 2021?

- Easy-to-use, on-line application, with underwriting answers in 72 hours or less
- Individual programs available, eliminating the need to offer group programs to employees
- Preferred rate tier available for ages 18-59 years old and Preferred Plus rate tier available through age 64 to respond to increasing medical insurance rates for individuals 50 years and older in the marketplace
- Twelve benefit designs, an HSA (Health Savings Account) and two network options; all the options are ACA-compliant — this is traditional insurance with 100% preventative care included (see the benefit outline on the chiropractic association website for details)

Why apply for the OSCA Chiropractor Medical Program?

- Chiropractors are healthier than the average population and the numbers over the past 6 years prove it in 30,000 member-claim months, there has only been one cancer and 6 claims greater than \$100,000.
- Chiropractors are small employers with roughly 2.5 employees participating per
 office; if you didn't have another employee to apply for medical insurance in past
 years, you can apply yourself in 2021.
- Chiropractors enjoy a low underwriting risk factor, and most can qualify for better

- rates than the modified community rates available in most states; most chiropractors are not eligible for subsidies due to their income.
- The program allows most employers to pay premiums on a tax-favored basis.

- Chiropractors have renewed coverage more than 98.5% every year of the program's 6-year existence

Legislative Updates



NEW ACA BILL H.R. 2654: The OSCA thanks all of our motivated and engaged members who have helped make our state and national efforts more effective through our Medicare Action Center and beyond! We must call your attention, once again, to the latest ACA-sponsored Medicare bill, H.R. 2654. This legislation allows Medicare beneficiaries access to the chiropractic profession's broadbased, non-drug approach to pain management, which includes manual manipulation of the spine and extremities, evaluation and management services, diagnostic imaging and utilization of other non-drug approaches that have become an important strategy in national efforts to stem

the epidemic of prescription opioid overuse and abuse.

The good news is that our voices have been heard for the past 3 campaigns! We need you to contact your representative again, to help pass this bill. It takes a minute and all you need to do is enter your address and hit submit! The email will be automatically sent to your own legislator. The more DCs to contact their reps, the better! Let's show Congress how united our profession is and support the ACA in this campaign.


