Regarding E/M denials by Medicaid on the same date as CMT:

ODM has acknowledged the current issue to impacted providers. FFS claims are not paying correctly due to the current core functionality of the NCCI editing engine. In order to pay for an E&M service and a spinal manipulation service on the same date of service, ODM must align its proprietary Claim Check edit with the national NCCI PTP edit. The national NCCI PTP edit allows a modifier override to allow both procedures to pay. ODM is currently in the process of implementing the necessary systems change. However, ODM is

also in the midst of a massive claims management systems replacement. After the systems work is complete, all impacted claims reported with an E&M service and a spinal manipulation service on the same date of service, from the effective date of the policy, can be resubmitted by providers.

Once the OSCA receives confirmation from ODM that this issue is resolved, we will notify members so that claims can be resubmitted for payment.

Molina Marketplace Takebacks

Molina Marketplace AT modifier recoupments are being repaid to DCs

Last month, we made the below announcement regarding Molina Marketplace and their recoupment campaign related to the AT Modifier. In addition to the update provided in October, the OSCA has confirmed that claims reprocessing is underway and anyone who experienced a claim denial or a recoupment should be expecting those funds to be returned to you.

- The anticipated completion of the project is roughly December 1.

October Update

AT Modifier: The OSCA continues to fight for members when payors initiate inappropriate recoupments and is pleased to provide the following update about the Molina Marketplace takebacks involving the AT Modifier.

OSCA is pleased to announce that ongoing conversations and meetings with Molina Marketplace has resulted in their decision to reverse their original position.

First, they have discontinued the automatic takebacks effective immediately. Second, they will be issuing automatic refunds to anyone that had takebacks automatically applied or deducted from current payments. You will not have to take further action for this as it will be completed automatically. We will provide a by-when date once we receive it from Molina.

Additionally, Molina Marketplace has acknowledged that the AT modifier is not required on CMT services.
