

<u>Office and Insurance Updates</u>

Important Ohio Medicaid Update!

Effective 1/1/19, all providers must maintain an active Ohio Medicaid number in order to receive payment from the Medicaid Managed Care Organizations. The Ohio Department of Medicaid (ODM) now requires that all health care providers participating in Ohio Medicaid and MyCare Ohio have an active Medicaid number. Further,



per ODM requirements effective January 1, 2019, Managed Care Plans (MCOs) such as CareSource, Molina, Buckeye Health, etc, will not be able to pay Medicaid or MyCare provider claims if the provider does not have an active Medicaid ID number.

Starting 1/1/19, having an active Medicaid number will be a requirement for all providers, new, and previously participating with the MCOs, for claims payment. Any services submitted to an Ohio Medicaid MCO (CareSource, Buckeye Health, Molina, etc.) rendered by a provider WITHOUT an active Ohio Medicaid Provider number will be rejected. You may not have the opportunity to re-submit these claims for payment.

What does this mean for you? Q&A

Q: Is an Ohio Medicaid provider ID number different than a Caresource provider ID number?

A: Yes. Upon enrollment with Ohio Medicaid, you will receive a provider ID number. Additionally, you will receive a provider ID number with EACH MCO that you choose to enroll.

Q: If I already have an active Ohio Medicaid number, do I have to do anything different?

A: No. When you submit your claim for payment to one of the Ohio Medicaid MCO's, they will cross-reference your information with Ohio Medicaid. Once it is verified that your Ohio Medicaid provider number is active, payment will be issued.

Q: Do I have to fill out my claim form differently after 1/1/19 for Medicaid/Medicaid MCO patients?

A: No. You will continue to bill Medicaid MCO claims as you did prior to 1/1/19. Verification of your active Ohio Medicaid number will take place by the MCO once your claim is received.

BWC Webinar on Timed Procedure Codes

If you missed the BWC Webinar from last month explaining the new timed procedure codes, you can view it <u>HERE</u>. This webinar explained what treatments will be required to document time-in and time-out. As a reminder, providers must now provide actual start and stop times for timed services to MCOs upon request. These new policies will be effective for bills received by MCOs beginning November 19th, 2019 <u>regardless of the date of service</u>. Please watch webinar for further clarifications!
