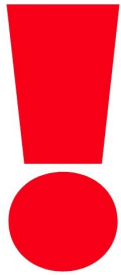

License renewal is coming up! All Ohio DCs must have 36 hours of continuing education, including 2 hours of ethics, by March 31, 2022! The Ohio Chiropractic Board will be conducting license renewal online once again this year. If you would like more details on this process, [please click here](#).

Insurance and Legislative Updates

Anthem Issues: The OSCA is in ongoing communication with Anthem regarding multiple payment issues affecting chiropractic offices. We are diligently working to resolve these issues with Anthem, and will update members as new information becomes available.

ICD-10 Updates: Our office is still receiving many questions about the ICD-10 updates affecting chiropractic offices. We have created a helpful document, also found in the upcoming OnTarget Magazine, to help your office navigate

these changes. This document has expanded explanations for the new codes. Please review this with your staff and ensure that everyone is familiar with these changes moving forward. [Click here for the updates.](#)

CareSource Policy: CareSource has been notifying offices that they are covering unlimited visits. While the OSCA was not made aware of any changes that would give chiropractic offices unlimited visits, we are currently working with CareSource to find clarity in this policy.

Medicare Schedule: The OSCA expects CMS to release the 2022 Medicare Fee Schedule in the next few weeks. The OSCA will send the information to members as it becomes available.

Legislative Update: The Ohio Senate has halted all votes on bills in the Senate Health Committee. This has affected the progress of OSCA's House Bill 136. In the previous hearings for House Bill 136, there has been no opposition from other organizations or legislators. We do still anticipate that our bill will pass prior to the end of the General Session this December.

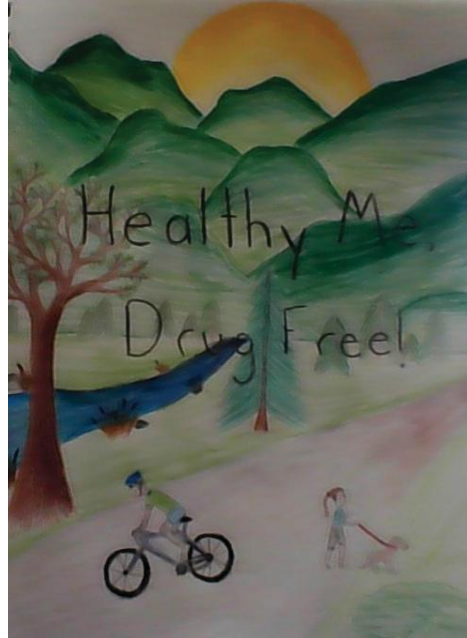

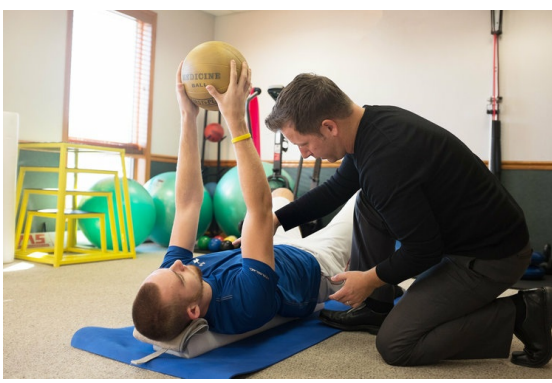
