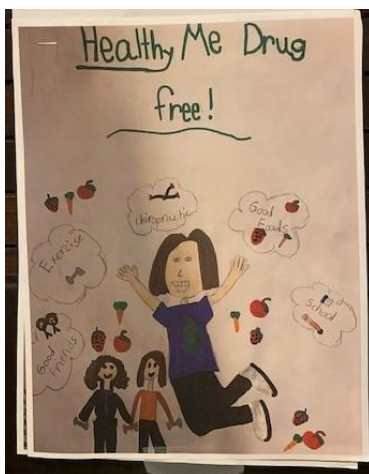

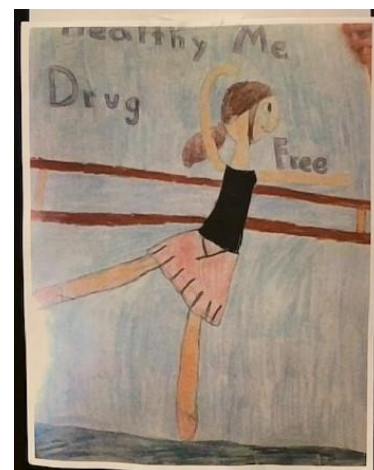

## Molina Marketplace Takebacks

AT Modifier: The OSCA continues to fight for members when payors initiate inappropriate recoupments and is pleased to provide the following update about the Molina Marketplace takebacks involving the AT Modifier.

OSCA is pleased to announce that ongoing conversations and meetings with Molina Marketplace has resulted in their decision to reverse their original position.

First, they have discontinued the automatic takebacks effective immediately. Second, they will be issuing automatic refunds to anyone that had takebacks automatically applied or deducted from current payments. You will not have to take further action for this as it will be completed automatically. We will provide a by-when date once we receive it from Molina.

Additionally, Molina Marketplace has acknowledged that the AT modifier is not required on CMT services.
