Office and Insurance Updates

Caresource Billing Issues

OSCA has spoken with Caresource regarding the current billing issue causing acupuncture services that should be paid to deny in error. They are actively working to resolve the issue and have given us a completion date of 9/24/18. Once the billing issue

is fixed, they will automatically identify all correctly submitted claims that were improperly denied and reprocess for payment. It could take up to 4 weeks to receive payment once reprocessed. No other action on your part is needed at this time. If you do not receive reprocessed claims for payment by the above quoted timeline, please reach out to Dr. Spaulding at brandy@oscachiro.org.

DME supplies for Medicaid

A recent letter went out to OSCA members that referenced DME specific to Medicaid. The OSCA is actively working with the Department of Medicaid to clarify the requirements necessary for Ohio DCs to enroll as an organization that is a supplier of DME. More details will be coming out soon on this topic.

BWC Lumbar Fusion Rule

Following the 2017 rule that would require anyone seeking lumbar fusion surgery to first utilize conservative care and receive a comprehensive clinical evaluation prior to consideration for surgery, the OSCA has now been made aware that BWC is keeping their promise and DCs who treat BWC patients should be receiving a letter with this rule language. The letter states that this rule is consistent with current best practices and was passed unanimously by the Spine Subcommittee and the Health Care Quality Assurance Advisory Committee. It emphasizes that patients are being made aware of their option to chose conservative care first and that it often is the best treatment for their injury.

...Did you know?

...if you carry a separate certification for acupuncture, how you credential, and therefore, bill your services with an insurance company could impact the reimbursement you receive? For example, if you bill under your identifying information as a DC, your reimbursement may fall under chiropractic benefits, including visit limitations, copay and deductible, and fee schedules. However, some insurance companies will allow you to credential/add an acupuncture specialty, bill with the identifying information specific to your acupuncture credential, and they have a separate fee schedule, visit limit, etc., for acupuncture services. Ohio Medicaid is an example of a payer that requires you to credential as a provider of acupuncture services and the visit limit is separate from chiropractic services. UnitedHealthcare is an example of a payer that has the option to do it either way, but your cap per visit will apply if you bill with your identifying information as a Doctor of Chiropractic.
